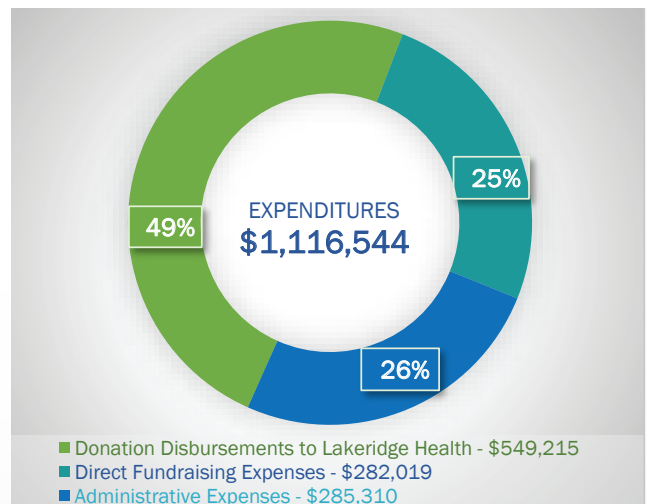
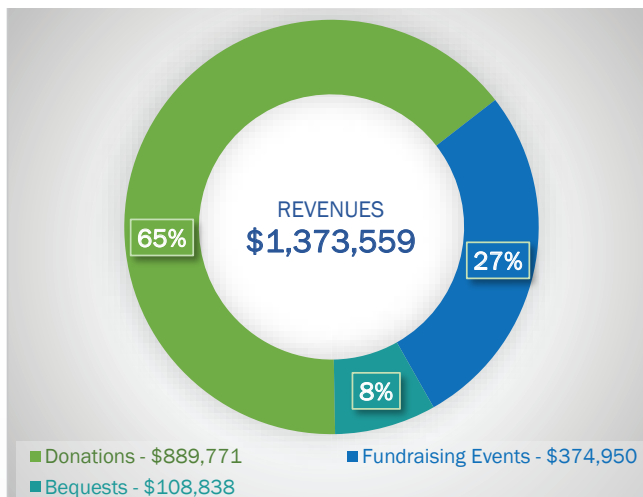
2019-2020 Highlights For The Year Ending March 31, 2020

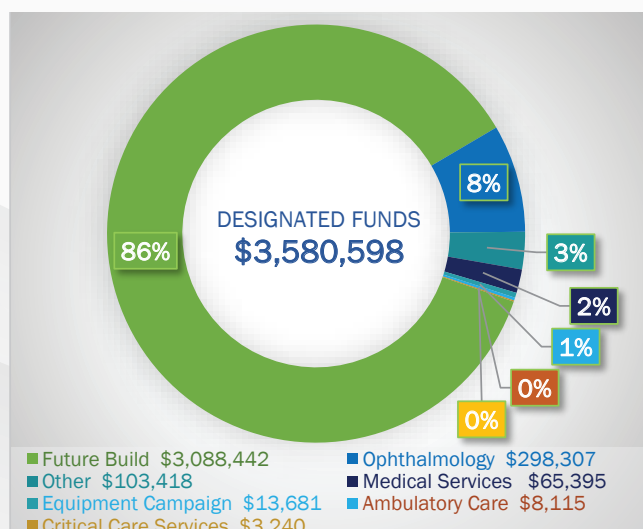

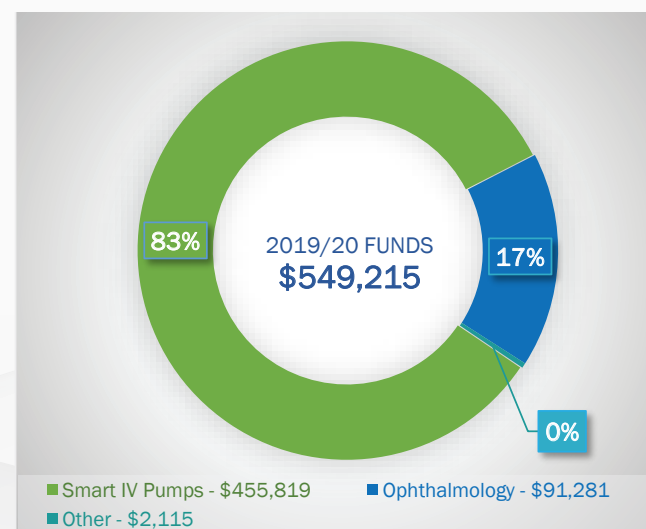

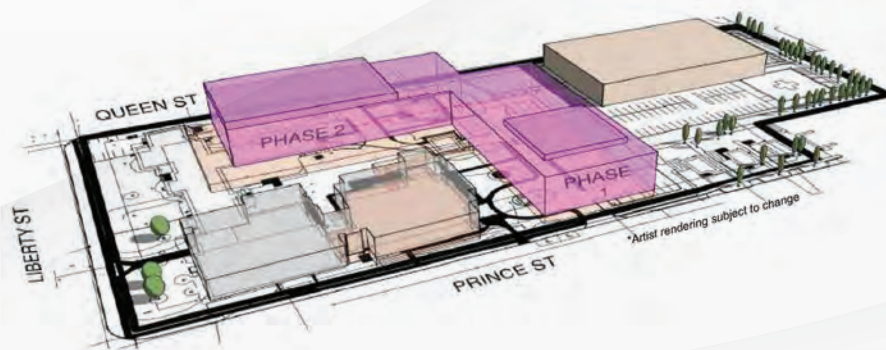
AN EXCITING ANNOUNCEMENT

In September 2019, Infrastructure Ontario identified the Bowmanville Hospital’s redevelopment and expansion project as a near-term priority project on the Fall 2019 Ontario P3 Market Update.

The campaign received another major boost from the **Halminen Family Foundation and Lakeside Self Storage**, long-time supporters of Bowmanville Hospital Foundation. The family made a **\$2-million-and-1-dollars** gift to the redevelopment project, setting yet another record for the campaign.

This means more patients in all phases of ventilation – controlled, supported and non-invasive – can benefit from advanced lung protective strategies.
